We do not sell your personal information to third parties. We may share the information we collect from and about you:

- With third parties that we believe may provide benefits, promotional materials, and goods and services that may be of interest to you, including with other nonprofit organizations;
- To service providers who work on our behalf and who have agreed to use the information solely to carry out the services that they are performing for us, including, but not limited to, outside contractors, auditors, consultants, and other third parties who provide financial or operational activities on our behalf;
- as necessary if we believe that there has been a violation of rights our published policies or terms
 of use or the rights of any third party;
- to respond to judicial process or provide information to law enforcement or regulatory agencies or in connection with an investigation on matters related to public safety, as permitted by law, or otherwise as required by law; and
- when we believe in good faith that disclosure is necessary (a) to protect our rights, the integrity of the Services, or your safety or the safety of others, or (b) to detect, prevent, or respond to fraud, intellectual property infringement, violations of our published terms of use, violations of law, or other misuse of the Services; and
- as described to you at the point of collection
- as you may otherwise permit or consent to.

We may sell or purchase assets during the normal course of our business. If another entity acquires us or any of our assets, information we have collected about you may be transferred to such entity. In addition, if any bankruptcy or reorganization proceeding is brought by or against us, such information may be considered an asset of ours and may be sold or transferred to third parties. Should such a sale or transfer occur, we will use reasonable efforts to try to require that the transferee use personal information provided through the Services in a manner that is consistent with this Privacy Statement.
